**3.2.1 Update on In-Person Learning.** Several parents spoke in support of having students attend daily in person school and the emotional concerns that they have with students attending distance learning. Mr. Newman and Mr. Perry addressed the concerns. Mr. Perry mentioned that there are several conflicts on the schedule to be worked out, but OHS is ready to combine both A & B schedules to allow in person students to attend class everyday; instead of being on an alternating schedule.

President Allen asked Dr. Garrison if the 6' guidelines have changed to allow more students in the classroom. Dr. Garrison stated that the guidelines have become more strict. Dr. Garrison mentioned that districts have to present a written request that details the reason why 6' is not able to be maintained to the County Health Department, and that all other options have been exhausted, so have the 6' guideline waived/changed. Dr. Garrison stated the State is the one to make the final decision.

Parents also asked if the State has made a decision if competitive sports are going to be allowed. Mr. Newman and Mr. Perry both addressed the parents and let them know that the District is still waiting on final determination from CIF. Mr. Perry mentioned that student athletes are able to participate in conditioning and practices as long as it is done in a safe manner, while maintaining social distancing.
