### 3. DISCUSSION/ACTION ITEMS:

3.1 Discuss Salary Schedule for Chief Business Official:

The District has contracted with School Services of California to help with the search for a new CBO. It is very difficult to find a local CBO, as there is a shortage. There is a high number of openings statewide for CBOs and Financial Officers. Even though the District's benefits are incomparable with other Districts, School Services has recommended the District increase the salary 7% to 10%.

School Services believes that the District will not be able to get a CBO with much experience. Without a more competitive wage the District may not find a CBO with experience or credentials. Trustee Brummet recommended either a moving bonus or a COVID bonus.

Trustee Reimers would like Mr. Newman to reach out to a local person that can be a potential candidate to see if they would be interested in applying. Trustee Reimers is in agreement to increase the lower end of the salary but would not like to offer a 7% increase. In larger districts the CBO does not oversee MOT and Student Nutrition. President Allen would like to offer an increase in the salary schedule, but not a 10% increase. Trustee Reimers agreed to increasing the salary schedule to \$120,000 on the lower end and a max of \$148,000.

Trustee Brummet made a motion to approve a salary schedule increase for the CBO of \$120,000 on the low end and \$148,000 max with a \$5,000 one time Transition Bonus.
