3. COMMUNITY-STAFF AND/OR PRINCIPAL'S REPORTS:

3.1 Certificated Representative/Classified Representative Reports:

Classified Representative Report: Barbara Crain presented CSEA report. In Crain's report she mentioned that it is great to have the students back all day at school. Negotiations are going good.

Certificated Representative Report: Mark Barnhart presented the OTA report. OUSD is currently using a traditional schedule. Barnhart wanted to clarify that OUSD instructional minutes were higher than any other district in the region. He also clarified that the rumor that OTA was against getting students back to school and that was not the case.

Barnhart stated that In this region OHS is the only high school that was doing both direct instruction and district learning at the same, because they felt that was best for students. There are over 110 students on Edgenuity and one teacher support of all the students. OTA would like to see more support for those students.

Barnhart reviewed COVID statistics.

3.2 Superintendent's Report:

Mr. Newman discussed schools re-opening back to full day in person instruction. There have not been any positive COVID cases since going back to full day. Mr. Newman thanked Trustee Brummet for her work in helping get the COVID vaccine to the District staff. The District is currently using King Consulting to help find a qualified architect. The District is currently piloting a program for Independent Studies, that helps students stay at the grade level standards they should be at. Mr. Newman mentioned possibly changing Independent Study from a packet approach to an online approach.

The District is currently looking for a long-term sub to help with the Edgenuity students, but there have not been applicants for that position. A search firm will be helping the District with the search for a new CBO. There is currently an interim CBO, until a permanent CBO is found.

The District is planning for an in person graduation. It has not been determined whether there will be a limit on the number of attendees. More information will be going out to the families as it becomes available. Graduation will be live streamed for those who are not able to attend.

Mr. Newman met with Dr. Garrison and Mr. Quarne. There will be a county-wide task force that is being formed to discuss the best approach to take when students are positive. Dr. Garrison has agreed that if the District is confident with its contact tracing then entire sports teams do not need to quarantine, unless tracing is not reliable. A negative test will not cancel a quarantine order.

Mr. Newman discussed the LCAP. The three main goals that the District has on the LCAP for 21/22 are instruction, social emotional learning and family engagement.
