5.4 Discuss District Instructional Aides - Last meeting it was requested that district instructional aides be on the agenda. There is no action, this is a discussion item only. Cara Kennedy-Langan came to represent the 1st grade team. Mrs. Langan distributed a copy of a letter that they had been emailed to the board members. Teachers are finding it hard to do their job. System is being overwhelmed. Students coming with needs that are already neglected at home. We are in great need of qualified instructional aides in first grade. With an instructional aide in the classroom these needs can be better met. Investing now will help students as they move through the district. One teacher juggling all of the issues students are coming with is too much. Mill Street needs aides in every classroom.

Alberto Gomez said that thinking back to his childhood years. His first year of school in the US was in 3rd grade. Looking back he always had 2 adults in the classroom. Made such a difference. Made for an easy environment. We've had a similar situation at Alt Classroom. CDS doesn't have an aide. Position was flown at the beginning of the year but no one applied for it. There has been times when she has had to call and have one of us cover for her if she needed to step out for a minute.

Trustee Brummet - I asked for this to be put on the agenda based on my previous experience teaching 2nd grade and my experience helping in my grandson's classroom. When I am in the classroom, especially during rotation stations, students go up to me and ask for help because the

teacher is busy helping other students. First grade is such a crucial age for reading. If we can afford it is a priority. At the board workshop they discussed us developing our goals and then coming up with a strategy. Having an extra person in the classroom can help the gap. In a safe environment. In mission and core values. Unfortunately nowadays we have so many students showing up with severe emotional trauma. There is a need in the classroom to help with that. I would like to have this as a discussion item at the May meeting after the May Revise. We can make a better truer decision and we can decide what we want to spend our money on. Trustee Vlach- I am in support and I see the need down there. How many aides, how many classrooms? What is the cost? I would like this to come back with more information.
