3. COMMUNITY-STAFF AND/OR PRINCIPAL'S REPORTS:

- **3.1** Student of the Month Recognition: Mr. Mercado presented Dioselin Nuñez-Mercado as the OHS Student of the Month. Dioselin has been in Leadership for 4 years. She was described as responsible, respectful, "the calm in the middle of the storm" and always has a positive spirit. Dioselin has taken all 8 AP classes that OHS has to offer. When Dioselin graduates she wants to attend a UC and major in biochemistry.
- 3.2 Principal's Report: Mr. Mercado shared his principal's report with the Board. OHS has achieved a high ranking in US News and Report. Ranked in the top 40% of high schools in the nation. The English department is administering the Benchmark test. The Math department is working on revising the Benchmark test. During Back to School Night this year OHS hosted a Senior Parent Night to go over graduation requirements. Partnered with Gear Up and brought in a taco truck. Mr. Mercado summarized the activities for Homecoming, Battle of the Axe and Suicide Prevention week. He also provided an update on all fall sports.
- 3.3 School Representative Report: Dioselin and Kaylin, both students at OHS, presented the School Representative Report. FFA is selling pork sandwiches this week. FFA is also getting ready to host Little Farmers and Farm Day for the 4th graders. FNL is attending the Youth Summit in Anaheim. Bring Change to Mind Club is attending a summit in Berkley. The students have been working hard to get their homecoming parade floats ready for tomorrow. The homecoming parade will take place tomorrow at 3:30 pm.
- 3.4 Certificated Representative/Classified Representative Reports:

Classified Representative Report: SheryInn Byker, CSEA President, said that CSEA is getting ready to submit an initial proposal to start negotiations. CSEA sent out a survey to their members. She was happy to see that several members stated on the survey that they view OUSD as a career. There are a lot of long term employees. The top 3 concerns were: wages/compensation, felt positive about insurance, and part time employees would like to get full time hours. Met with members at all of the campuses. There are several members who possess higher education degrees and others who have job skills from other outside jobs. Byker stated that their members step up to serve whenever there are gaps that need to be filled. Work overtime when emergencies arise, and they put students first. Want to move up within the district.

Certificated Representative Report: Jason Bragg, OTA President, said that things are rolling right along. People are happy to be back in the classroom. Bragg is happy that they've been able to solve problems as they come up.

- **3.5** Orland McDonald's to Present Check to OUSD Jordan Ruiz, owner of the Orland McDonald's, and General Manager Mary presented OUSD with a donation check of \$3,200 from the sales of french fries during their grand opening. Ruiz stated they love being a part of the community. They have 65 employees. Employ over 20 minors. The quality of minors at the restaurant is amazing.
- **3.6** Superintendent's Report: Superintendent Perry invited Mr. Moore and Mrs. Thompson to share with the Board how to videos that the Auto Shop class students have created. Mr. Moore and Mrs. Thompson explained how they are incorporating technology into the classroom. Auto shop students created and produced videos in which they provide step by step instruction on how to complete different auto tasks.

Trustee Vlach tanked both Mr. Moore and Mrs. Thompson for incorporating technology into the classroom.

3.7 Facilities Update - Superintendent Perry stated that the district staff is completing a study of all of the campuses. They are actively working on compiling a stakeholders list to make a Superintendent's Facilities Committee. Will be reviewing building types. Have submitted an application for the TK/PK Funding Grant. Currently awaiting a funding allocations meeting. Superintendent Perry also stated they are actively working on submitting funding applications for recently completed modernization projects.
