There is a 2 hour online course prior to the in person. We will have a board workshop that will start at 3:00 prior to the February board meeting. Sgt. Johnson, who is an official trainer for Alice, will need two hours for the training. We will figure out the best way to share this information district wide.

<u>Banking Day</u> — We have been partnering with Enterprise, they are helping us design the role of our ed tech coach. We have six that are interested in applying. Yesterday TK-5 had their tech time with the coaches from Enterprise and our own teachers ran the session, which is a big step as we are trying to build internal capacity in teacher leadership.

We are working with DSLT to refine our instructional focus as we look to testing in April. Trying to identify one or two instructional strategies that will yield results. We will be doing instructional rounds with Mary Black and administrators going in rooms to identify our PD needs.

In January, Karen and Ken will be attending the Governor's budget. The forecast looks healthy for schools next year. In January we will start looking at staffing for the 2018-19 year.

- 7.1 LCAP Technical Assistance Dr. Geisick shared that we have a new testing program called California Dashboard. Anyone can go online and pick any school and see how they scored. Shirley Diaz, from GCOE, notified us that we are in technical assistance. This is the accountability measure of the LCAP and LCFF funding. We fell into this TA as we had one group that received three reds. Our English Learners ELA scores and math scores were insufficient and their suspension rate is higher than other groups. All we need to do for technical assistance is confer with the county office of ed, she comes and does a strengths and weaknesses with administrators. There is nothing else that needs to be done at this time. In January, Shirley will meet with the leadership team. We will keep monitoring it.
- **7.2** SELPA Update The data has come back from the fiscal office and what they are able to do is make some one time changes. The concern is that it's not sustainable. There are potential options and opportunities.
- **7.3** OHS Tutor Me Center Principal Victor Perry gave a presentation on the tutoring program that will start at the high school on January 9th in the career center. Flyers have been distributed.
