3.2 Superintendent's Report:

Dr. Geisick reported that tonight we have the LCAP hearing, we have an LCAP Addendum that he is completing that needs to be approved by August. It is a requirement to get Federal funding.

Tracy Sailsbery and Ken will be attending an ESSA (Every Student Succeeds Act) workshop next week, there are a lot of laws rolling out particularly around persistently low performing schools. We want to become very aware as we don't know where Orland will land. They are looking for 300 schools across the State to identify.

Christina Mesker and Ken spoke with an expert in the field on social emotional learning. We are seeing increased behaviors that we probably didn't see a generation ago. We need the administrators to get a framework around this as to what we do in the classroom, what kind of strategies outside the classroom, how we engage with families. Wendy Anderson will be the new coach and we want to give her support.
