- **6.1** Local Dashboard Data Dr. Geisick reported that last month we had a board workshop around the California Dashboard which really changes the way we look at schools and progress. There are indicators that we are accountable to. One of our goals is how to create a local dashboard that will give us indicators of where we will land. Dr. Geisick went over the data.
- **6.2** SELPA Update Dr. Geisick reported that he thinks that we have finally made a breakthrough in terms of clarity and transparency. It gives us some benchmarks how we can reduce our costs by taking on some students ourselves. If SELPA and Financial committee adopt, it will go into effect next year. We are trying to move to a fee for service per pupil model. The old model, we got a bill and there was no way to understand the excel spreadsheet. This does create a much clearer and transparent way of conducting business. If we can get a preschool open and its budget neutral next fall and we can serve some of the students that are in the county program. We are exploring ideas to get the numbers down without taking over the program.
