# 6. INFORMATION/DISCUSSION:

- **6.1** SELPA Update Dr. Geisick doesn't have new information, we are still waiting for the updated calculations from the external expert.
- **6.2** LCAP Local Measures Dr. Geisick reported that each November we have to have local measures. They have added a new one so we had to create a new measure. We have a parent engagement survey, for implementation of common core state standards we do a staff survey through DSLT, broad course of study we are using AG completion rates, elementary access to English Language Arts, Math and Music and adoption of common core materials. For student engagement we have been using Healthy Kids survey.
- **6.3** Re-Entry into Medical Administrative Activities (MAA) with the Region 2 Local Educational Consortium Dr. Geisick reported that over the years MAA generated some revenue. The federal government has come in and is doing back casting and have determined that we were overpaid. We don't pay it back; they take it out of our one-time money. We think with the random moment in time, we can get around \$60,000-\$80,000 a year and possibly recoup some of the money.
